SOLICITOR'S REPORT

The Solicitor had prepared two items of legislation for Council's consideration. The first item for consideration was the purchase of two Police vehicles. There was some discussion around this issue.

RESOLUTION # 33 – 2015 Purchase of two Police Vehicles from Ford Motor Co.

A motion to Adopt Resolution #33-2015, a Resolution Authorizing the purchase of two police vehicles from Ford Motor Company for an amount not to exceed \$65,245.00 was made by Ms. Meister; seconded by Mr. Myers. ALL IN FAVOR.

Next Mr. Hyle recommended Council Accept the Bid Package for Garbage Pickup from Rumpke. There was some discussion about the two options in Rumpke's package and about a new service fee. Council wants to negotiate the contract further with Rumpke and revisit these issues at the next council meeting.

Village Administrator, Michael Rahall talked about the Salt Contract for the Village. The Village will be going through Hamilton County this year and pay for what salt we use when the season is over. We have 80 tons of salt carried over from this past year.
