# **VILLAGE ADMINISTRATOR'S REPORT**

Village Administrator Mike Rahall reported that there was an open house last week as part of the OKI Grant. The open house was to inform residents of ways to save money on energy costs. The Village will receive \$15,000 from OKI as part of the program and that can be used to reduce the Village's energy costs. Mr. Rahall also reported that there have been some issues on E. State Road with water main breaks, MSD repairs and a tree falling. These problems are due to the hill slipping underground. Mr. Rahall is trying to secure emergency money from the county to help pay for these costs. The former Casa Loma Bar, now called Jacki's, has reopened. There was a brief discussion concerning the status of the gas station being built on Kilby Road.

#### **DEPARTMENTAL REPORTS**

#### POLICE

Chief Jones gave his stats for the month. Chief Jones is planning an active shooter drill to be held at the school. The Police Department is also going to do some training at the County's facilities that requires special ammunition. Chief Jones spoke to Council concerning the need for new radios for the Police Department. The current radios will be unusable very soon. The Village can purchase new radios through a five-year lease program. Council approved the lease for the radios. Chief Jones also spoke to Council concerning the need for new Tasers for the Police Department. Several of the Tasers are outdated. There was discussion concerning purchasing or leasing the Tasers. Council approved a five-year lease for the Taser purchase.

#### FIRE

Chief Ober gave his stats for the month.

#### **SERVICE**

Service Director John Knuf reported that the Service Department has been cleaning up litter and patching potholes. The department also swept Miami Avenue from end to end. Mr. Knuf is going to get quotes for street sweeping other streets in the Village.

#### WATER

Water Superintendent Eric Winhusen reported that 34 million gallons of water was pumped last month. The Shawnee/Lower River Road Project is complete. There is just a final punch list to review. The Coleberry Court Booster Station is 3/4 complete.

The committees will use an online scheduling system to schedule meetings. Mayor Rouse asked Council to meet to set goals for the Village. The meeting will be March 6<sup>th</sup> at 7 P.M. in the Council Chambers. Mayor Rouse informed Council that the upcoming levy renewal would cost homeowners less than the current levy. There was a discussion concerning a mailing to residents about the levy. Mayor Rouse thanked Mr. Myers, Ms. Myers and Mr. Rahall for attending the William Harrison event on behalf of the Village. Mayor Rouse also acknowledged the following service anniversary:

Mayor Rouse thanked Mr. Laws for his service to the Village. Finally, a group of students from Three Rivers Schools is going to paint the gazebo as part of a service project for the Destination Imagination program.

# **COUNCIL REPORTS**

<u>Three Rivers Schools:</u> Mr. Myers reported that Mr. Baggett discussed the course registration guide at the last board meeting. There was also a presentation about the new college credit program between Taylor High School and the University of Cincinnati. Mr. Myers also reported that he updated the staff and elected officials' pictures on the Village's website.

**Bicentennial:** Mr. Burns showed Council the banners that he created to advertise the event. There was also an example of a banner that people or businesses could purchase. The donation letters have been mailed. They have received two donations so far. The committee is going to spend this month working on donations. A cookbook has been discussed as a possible fundraising opportunity. Mr. Burns reported that the current schedule of events for the Bicentennial Celebration on July 14th are: 5k Run, Parade, Car Show, Picnic and Fireworks. Mr. Williams discussed the car show. He is creating a flyer to be handed out at other local car shows.

<u>Planning and Zoning:</u> Ms. Myers informed Council that demolition had begun at 75 Harrison Avenue. However, asbestos was found during the early phases and demolition had to be stopped. They are trying to secure funds to pay for the asbestos removal. Ms. Myers reported that at the last Planning and Zoning meeting the Tisch Properties were discussed. Ms. Myers also mentioned the possible need to add items to the Zoning Code concerning medical marijuana.
