THREE RIVERS SCHOOL DISTRICT REPORT

Mr. Craig Hockenberry reported that school begins August 20th. There are new start times and dismissal times for school. The school is working on a three to five year strategic plan. Mr. Hockenberry thanked the Village for collaborating with the school to provide two SROs. School enrollment is surging. There are approximately 2,400 students at Three Rivers this year. Mr. Burns thanked Mr. Hockenberry and the school for allowing the Bicentennial Committee to use their facilities for the 5K run.
